

# **OnTheHub's "Drop The Debt Giveaway"**

These are the official rules for the 'OnTheHub's "Drop The Debt Giveaway"' Sweepstakes. This promotion will be referred to as the "Sweepstakes" throughout the rest of these rules. In these rules, "we", "our", and "us" refer to OnTheHub (as part of Kivuto Solutions Inc.), the sponsor of the Sweepstakes. "You" refers to a potentially eligible Sweepstakes entrant.

# About the Sweepstakes

OnTheHub is very excited that the winter back-to-school season is here! To share in our excitement, we're giving away \$500 gift cards each week for five weeks. Enter the promotion on our Sweepstakes page. There are multiple ways to earn entries into the sweepstakes; make sure you complete all of the activities to increase your chances to win!

# **Sweepstakes Period**

The Sweepstakes is run by OnTheHub and will take place in the United Kingdom, the United States, excluding Rhode Island, and in Canada excluding Quebec, from 10:00 EST January 4, 2022, to 23:59:59 EST February 7, 2022 (the "Sweepstakes Period"). This Sweepstakes is void where prohibited.

# **Sweepstakes Sponsors**

For the purposes of the Sweepstakes, the "Sweepstakes Group" is composed of the Sponsors and Kivuto Solutions Inc. (as OnTheHub) together with its affiliates, including without limitation its parent, sister and subsidiary companies, retailers, franchisees, advertising and promotion agencies, suppliers of material and services related to the Sweepstakes, and any other corporation, partnership, sole proprietorship or other legal entity directly involved in the Sweepstakes and their respective employees, agents, and representatives (collectively, the "Sweepstakes Sponsor(s)"). # Eligibility

The Sweepstakes is open to students who: (i) reside in any state or territory within the United Kingdom, United States, excluding Rhode Island, or in Canada excluding Quebec; (ii) have reached the age of majority in the state, province, or territory in which they reside, as of the date of entering the Sweepstakes; (iii) have read and accepted the Official Sweepstakes Rules.

# How to Enter

To enter the Sweepstakes, users need to visit the promotion website (https://onthehub.com/drop-the-debt/) and enter using the widget located on the page. Users can enter the Sweepstakes using their email address or their Facebook, Twitter, or Instagram account. One email address must be used through the duration of the sweepstakes; failure to do so will lead in disqualification.

Entrants have the opportunity to receive 46 entries for each week's prize Entrants must submit entries to each week's giveaway independently from the previous week. Entries from all weeks will be compiled for the final grand prize draw. One email address must be used through the duration of the sweepstakes; failure to do so will lead in disqualification.

- 20 Entries: Making a purchase on OnTheHub.
- 1 Entry: (Total 7) Vising the contest page daily.

### NO PURCHASE NECESSARY TO ENTER OR WIN - ALTERNATIVE MEANS OF

**CONTEST ENTRY**: Individuals may receive twenty (20) entries for the Sweepstakes by legibly printing the contest week, Entrant's name, street address, city, state/province, zip/postal code, telephone number, and complete email address on a 3 x 5 inch (or 7.5 x 12.5 cm) piece of paper and mailing it to Kivuto, 495 Richmond Rd, Suite 100, Ottawa, ON, K2A 4H6, Canada. Please note the correct contest name ("OnTheHub Drop the Debt Giveaway 2022") is necessary to identify the specific contest being entered. Mail-in entries that omit this information will not be valid. All mail-in entries must be postmarked by February 7, 2022, and received by February 14, 2022.

All entries accumulated during the promotion period will be entered into the grand prize draw. There are a total of 230 entries that can be earned during the promotion period. This Sweepstakes is for verifiable students only.

## **Prizes**

There are six (6) prizes available to be won in the Sweepstakes. There are five (5) weekly prizes, each valued at \$500 in the winner's national currency (either USD, CAD, or GBP). The total value of available prizes is \$2,500.

# **Awarding of Prize**

To be declared a winner, a selected entrant must, in addition to meeting the Sweepstakes eligibility criteria and otherwise complying with the Official Sweepstakes Rules:

a) Be reached by email by the Sponsor or its representatives within ten (10) days immediately following the selection of the entry; b) Sign up for <u>the OnTheHub eStore</u> (it's free) to verify your academic status; c) Sign the Sponsor's form of declaration and release, which must include a witnesses signature (a witness is a person of your choice who must be 18 years of age or older), by completing all required Schedules and returning it to the Sponsor or its representatives at the address indicated on the Declaration and Release Form within five (5) days following its delivery by the Sponsor or its representatives.

**Disqualification**: If any one of the conditions mentioned above is not met, the selected entrant will be disqualified and shall not be entitled to receive any prize, and the Sponsor reserves the right, in its sole and absolute discretion, to select at random another eligible entrant as a potential prize winner.

**For Canadian Residents**: Entrants selected to be awarded a prize must successfully answer a skill-testing question. If a selected entrant cannot be reached within 72 hours of the random draw, declines the prize, incorrectly answers the skill-testing question, or fails to meet any of the contest conditions, his/her entry will be voided, and another selected entrant will be randomly chosen from the remaining valid entries. In order to be awarded a prize, each selected entrant must correctly answer, without mechanical or other assistance, a time-limited mathematical skill-testing question to be administered by telephone, e-mail, or mail at a mutually convenient time.

**Prize Delivery**: Following receipt of the selected entrant's signed Declaration and Release Form, the Sponsor or its representatives will send to the winner a letter informing him or her of the method by which he or she may take possession of the prize. # **General Terms and Conditions**

In the event that it has been determined that an entry has been made in any manner not sanctioned by these rules and/or an entrant has submitted more than the number of entries permitted by these rules, the entrant and all of his/her entries will be disqualified. Any entrant or other individual who enters or attempts to enter the Sweepstakes in a manner which is contrary to these Official Sweepstakes Rules or which is otherwise disruptive to the proper operation of the Sweepstakes or by its nature is unjust to other entrants or potential entrants will be rejected, and that entrant or purported entrant will be disqualified. All entries become the property of the Sponsor and none will be returned.

**Substitution of Prizes**: The Sponsor reserves the right, in its sole and absolute discretion and for any reason whatsoever, to substitute for any prize, or part thereof, a substitute prize of equivalent or greater value, including without limitation a cash award.

**Number of Prizes/Winners**: By entering the Sweepstakes, each entrant agrees to be bound by these Official Sweepstakes Rules and also acknowledges that the Sweepstakes Sponsor shall not be required under any circumstances to award more prizes than the number of available prizes, as set out in these Official Sweepstakes Rules.
